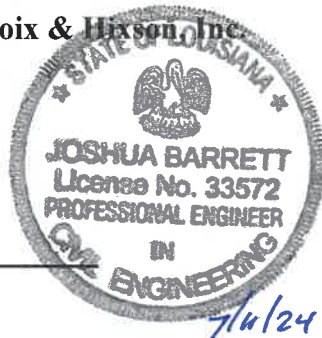

Remove existing Penta controllers and backup units

- b. Replace with two (2) new Global Com Controllers. Primary and backup
- c. Provide one (1) new IED Amplifier Frame (Dante)
- d. Provide 10(10) 2-channel amplifier cards (Dante)
- e. Provide one (1) analog to Dante Converter for owner provided AUX audio (Fire alarm)
- f. New CAT6 cabling to all equipment as required
- g. Provide 3 (three) years of licensing and annual maintenance licensing fees for the above.
- h. Configure, program, commission, and train the airport personnel on new head-end system.
- i. Perform work at a pre-determined off-peak time and date(s) as agreed upon by all parties.
- j. As a part of this contract, the contractor shall include in the lump sum price all costs associated with the requirements of these contract documents including but not limited to equipment costs, labor, bonds, insurance, training, testing, documentation, licensing, and maintenance. The contractor shall have previously completed similar work.
- k. The Contractor is responsible for the legal disposal of the existing equipment that is being replaced. Excess materials, trash, etc. shall be daily removed from the work areas.
- l. The Contractor shall attend a pre-construction meeting with airport personnel and the engineer to discuss the schedule and security procedures.
- m. The Contractor shall submit a work plan, drawings, and equipment information to the engineer and owner for approval.
- n. The Contractor shall be compliant with manufacturer's written instruction, applicable standards/ specifications and in accordance with recognized industry practices.

1.2 Training and Documentation

The Contractor shall conduct a training session at the completion of installation. The Contractor shall also assist and supervise airport personnel in a run-through of typical operation of the equipment to acquaint and further train them in a "hands-on" learning environment.

All audio/video wiring shall be numbered and labeled. The system diagram will include the wire numbers.

The Contractor shall provide system diagrams and equipment manuals including operations and maintenance in electronic and hard copy formatting.

Contractor to provide a one year, from the date of Substantial Completion, warranty on installation and equipment.
